ABOUT

Mary Keeney's practice area is litigation, both in the courts and before administrative agencies. Her primary focus in recent years has been on summary judgment proceedings in state district courts and a wide variety of appeals.

Ms. Keeney has represented property owners as well as governmental agencies in property disputes, including a successful challenge to the City of Austin's attempt to impose the Barton Creek Watershed Ordinance on a protected development project. She has also successfully represented the City of Lampasas in disputes over wholesale water contracts as well as the Lost Pines Groundwater Conservation District in the granting of a permit. Her real estate litigation practice includes representation of royalty and mineral interest owners in disputes over leases and the extent of property interests held by those clients. She has also represented a major telecommunications company at the Public Utility Commission (PUC) and in state and federal courts on a wide variety of issues and has represented and counseled electric utilities in litigation arising out of the 1999 legislation introducing retail competition.

Ms. Keeney's practice encompasses a wide range of substantive law that includes workers' compensation insurance, real estate, oil and gas, telecommunications, and water law. Her experience includes 10 years with the Texas Office of the Attorney General (1990-2000), representing various state agencies that include the PUC, the Railroad Commission, the General Land Office, the Motor Vehicle Board, and the predecessors to the Texas Commission on Environmental Quality.
